LEGAL BASIS AND PURPOSE OF PROCESSING

Furthermore, with your explicit consent, the personal data provided will be processed:

DATA RETENTION

Furthermore, in order to protect the data from destruction or loss (including accidental) as well as to ensure its integrity and confidentiality (including against unauthorized access or disclosure) and in general to ensure the rights of the data subject, the Data Controller has adopted security measures of a technical and organizational nature, in accordance with the provisions of the EU Reg.
